DEADLINES

- April 15** is the registration deadline.
Registrations should be received and deposits paid in full by this date.
Neither application fees nor deposits will be refunded after this date.
- June 30** is the payment deadline. The sum of \$100.00 will be added to ALL fee balances outstanding after June 30, 2009.

PAYMENT SCHEDULE

Applications submitted before April 15, 2009, must be accompanied by at least a \$200 application fee per week, if this has not been previously paid. Any remaining balance on the full deposit(s) will be due by April 15.

Applications submitted on or after April 15, 2009, must be accompanied by at least the full deposit(s) less any application fee(s) previously paid.

CANCELLATIONS

- Deposits and application fees are non-refundable after April 15, 2009.
- Balances will be refunded if cancellation notice is received on or before June 30, 2009.
- 50% of balances will be refunded, if cancellation notice is received between July 1 & July 15, 2009 (incl.).
- No refunds will be made, if cancellation notice is received after July 15, 2009, or in the event of withdrawal during the school. We strongly recommend that you investigate trip insurance coverage if there is the slightest chance you may not be able to attend.

EXCEPTIONS

- If a cancelled reservation is subsequently filled from a waiting list, a **full refund**, less a \$50.00 cancellation fee, will be made.
- If there is no waiting list, every effort will be made to award a full or partial scholarship to the current summer school in the amount already paid by the canceling prospective participant. The prospective participant may designate the recipient.

NOTES

- All fees are per person per week (Wk1: July 26 – August 2, 2009; Wk 2: August 2 – 7, 2009).
- Accommodations are offered to non-participants on an availability basis - usually when chaperoning or accompanying a participant. Decisions will be made on an individual basis.
